### **Transportation:**

- 3) Bob concluded that the Safety kit also should be turned over to Jeff.

# Security and Safety:

- 3) Ron Carter found the Fire Marshall must approve modification to the set of double doors from Club Room to the hallway..

# **New Business:**

### General discussion followed on the issues listed below:

- 1) Dennis suggested that the use of Flex vehicle should be done by Jeff.
- 2) Dennis also said that any response of the tram issue should be referred to Jeff.
- 3) Ardette said the traffic speed in GVT is dangerous to residents and needs correction somehow.
- 4) Bob Cobe raised concerns of Front Desk personnel usage and their ability to adequately cover security.
- \* It was suggested members contact other communities for information and possibly visit them for ideas.
- \* We definitely want to get Angie involved in contacting other communities on how they handle security.
- \* Jeff needs to be directed to rethink how to improve using our cameras for proactive security, not reactive.
- 5) Bob suggested we need to add a way to communicate with drivers parking at loading doors 2 and 5
- 6) Ardette Isler stated that cameras are needed at GVT's main entrances to keep buildings and residents safe.
- 7) Ardette said a security breach exists with all GVT main entrance doors being on a similar 4-digit code.

Chair Brady declared the meeting adjourned at 3:34 PM.
